SUPPLIER REGISTRATION FORM

Supplier Registration Form Frequently Asked Questions:

Q. When is a Supplier Registration Form Required?

A. Ontario Northland requires a Supplier Registration form to be completed for all suppliers who wish to conduct business with Ontario Northland.

Q. What needs to be completed by a New Supplier?

A. All fields in the Supplier Registration form are to be completed by applicant. Missing fields could result in disqualification of Vendor registration.

Q. Do I need to submit anything else along with the Supplier Registration Form?

A. Along with the supporting documents listed, your EFT information is required if you are enrolling for EFT direct deposit. Copies of your ISO or AAR Certificates should be included if you are actively enrolled.

Q. How long does it take to become a registered vendor and assigned a vendor ID?

A. Ontario Northland is committed to reviewing and returning your approved registration form as quickly as possible. To prevent any delays processing your submission please ensure that the form is complete and all supporting documents are included to the best of your ability. The review of your submission will not begin until all relevant information has been completed.

Q. Can I supply services or materials if I am not a registered supplier?

A. Services and/or supplies to Ontario Northland should only commence once a purchase order or contract number has been signed and issued. A Purchase Order cannot be issued until a Vendor ID has been assigned by our Shared Services group.
