RE: Clarifications/Questions

Please refer to the following information / clarifications:

Item 1: The scope of work describes non-intrusive sampling. For a building that is planned to be demolished, concealed materials not captured in a non-intrusive sampling may pose risk to the project during demolition. Please advise if intrusive cuts are expected for buildings planned for demolition.

Answer: Intrusive destructive testing is required at the following buildings:

- Fraserdale Toolhouse;
- Gardiner Toolhouse;
- Kirkland Lake Storage Shed;
- Larder Lake Toolhouse;
- Matheson Toolhouse;
- Otter Rapids Toolhouse; and,
- Otter Rapids Supervisor Bunkhouse.

All other buildings require non-intrusive and non-destructive testing only to be performed.

Item 2: If intrusive cuts and select destructive sampling are expected, please confirm that exterior of the building, including the roof system is expected to be included in the survey.

Answer: Any exterior surface that is cut needs to be repaired so it is watertight. If exterior shingles are removed to be sent for testing, cover with tar to prevent additional water damage.

Item 3: Are the buildings planned for demolition occupied?

Answer: The buildings planned for demolition are being used as storage.

Item 4: Are there any past surveys that can be shared before bid closing?

Answer: No. ONTC will only share applicable surveys with the Successful Respondent.

Item 5: Are all sites and buildings readily accessible by vehicle?

Answer: Yes, all buildings have road access.

Item 6: Would you be able to provide a list at this time as to which of the 41 structures are scheduled for demolition, which are to be renovated and which are to undergo maintenance and repair operations as this will affect the type of DSS/level of effort/pricing.
