**RE: Clarifications/Questions** 

Please refer to the following information/clarifications:

**Item 01:** Is the respondent allowed to quote solely for Item No. 01 – One (1) New Electric-Powered Multi-Directional Flat-Free Tire Forklift?

**Answer:** Yes, the respondents may submit a bid for just one unit.

**Item 2:** If a vendor chooses to only bid on one (1) Forklift then would that reduce the chance of winning the BID as we won't get any points from the other 2 units?

**Answer:** No, all units will be evaluated and awarded individually. ONTC may opt to purchase one or more units from the same vendor.

## **Item 3:** Part 3 – RFQ Specifications – Schedule 3-A – Scope of Work – Specifications – Required Features – Capacity

- Item No. 01 One (1) New Electric Powered Multi-Directional Flat-Free Tire Forklift
- a) Minimum gross rated capacity of 6,000 lb @ 24" Load Centre @ 276'. Would this be 276" (inches) instead?

**Answer:** Yes. This would be 276" (inches)

Please replace the 276' (inches) with 276" inches in the RFP Package for this Item No. 01 - One (1) New Electric Powered Multi-Directional Flat-Free Tire Forklift.

b) Please confirm if you would need the truck to be able to lift its full capacity of 6000lbs all the way to 276" or the capacity can be reduced at maximum height?

**Answer:** ONTC does not intend to lift 6000lbs at 276". In your submission, please list or detail weight capacities at various heights or mast stages. The unit however must be able to lift in the first stage 6000lbs and move this load without issues.

- c) Please confirm if the below specifications are required for this Item No. 01 One (1) New Electric Powered Multi-Directional Flat-Free Tire Forklift
  - Engine Heavy duty, industrial, electric powered engine, liquid cooled and High capacity radiator with coolant recovery system

**Answer:** Item No. 01 - One (1) New Electric Powered Multi-Directional Flat-Free Tire Forklift is to be fully electric. ONTC is unsure if this unit still requires cooling features or any required fluids. This specification may be adjusted based on the unit proposed by the respondent.

d) Can the lead-time be extended for this unit?

**Answer:** No, the unit must be delivered by May 30, 2025. ONTC is unable to extend the lead time.
