Please refer to the following information/clarification:

Item 1: Please confirm that Section 32 33 00 Site Furnishings should be deleted, and items are to be as per Section 12 93 00 Site Furnishings and quantities as noted in the FFE Drawings.

Answer: Specification 32 33 00 will be removed from the package in the next addendum. Use specification 12 93 00 for site furnishings.

Item 2: Was any contaminated soil observed during the investigation phase of the project?

Answer: Please refer to the Soil and Groundwater Characterization Report provided with the tender documents which provides the applicable site condition standards and details whether or not they were exceeded in the samples collected at the Timmins-Porcupine Station site. Proponents are also reminded of their responsibility to submit a contamination management action plan as detailed in specification 01 35 41 – ENVIRONMENTAL PROCEDURES.

Item 3: Section 22 05 7 Item 1.1 Work Included: Arrange and pay for all service connections. Can you confirm if it is the G.C. or the Mechanical Trade who is responsible for these costs?

Answer: This is at the discretion of the Proponent given the scope of the work includes all work including the work to be undertaken by the Mechanical Trade. The cost of the work should be included in the Proponent's pricing.

Item 4: Section 20 08 00 item 1,1,11. "The Contractor will hire and pay for a Commissioning Agent." Is the GC or the Mechanical responsible for procuring the Commissioning Agent?

Answer: This is at the discretion of the Proponent given the scope of the work includes all trades including the work to be undertaken by the Mechanical Trade. The cost of the work should be included in the Proponent's pricing.

Item 5: Are the OWA acoustical ceiling products by Spectra-con Group Inc acceptable alternates to Armstrong?

Answer: Any material replacement will be done according to the specifications. It is subject to review and acceptance on a case-by-case basis as per specification 01 33 00 clause 1.04.

Item 6: Would ONTC consider providing a two-week extension to the RFP Closing Date?

Answer: Yes, ONTC will agree to a two-week extension of the Submission Deadline / Closing Date for RFP 2024 069. The new Submission Deadline / Closing Date is Thursday, February 6, 2025 by 2:00:00 p.m. EST.
