Please refer to the following information/clarification:

Item 1: If we will not be able to meet the Phase 1 deadline, will we be charged liquidated damages? If so, when do the liquidate damages end? When we achieve Phase 1?

Answer: Please note that ONTC has now extended the Substantial Completion Date and Ready-for-Takeover Date for Phase I of the project. The new dates are as follows:

Phase I Start Date	February 2025
Phase I Substantial Completion Date	May 2, 2025
Phase I Ready-for-Takeover Date	May 9, 2025
Phase II Start Date	April 2025
Phase II Substantial Completion Date	July 21, 2025
Phase II Ready-for-Takeover Date	July 31, 2025

Please note that ONTC has now updated Part 4 – Proposal Form 10 – Schedule and Proposed Approach. Please replace Proposal Form 10 of the RFP package with the Proposal Form 10 attached to this Addendum at Appendix B. Proposals which do not include the proper Proposal Form 10 may not be considered.

Please refer to Section 10.4 of the Supplementary Conditions for information on Liquidated Damages.

Item 2: Drawing A1.0 – sub clause 6 states that the "rest of the building is still in operation". Are there people working in the building while we are performing our work?

Answer: ONTC employees will be working only in the shop area. Other areas will not be occupied during construction.

Item 3: Sub clause 11 states that "below deck roof insulation and vapour barrier to be removed throughout entire building" please confirm that this is correct as D6 & D11 notes indicate this work will be completed in only certain areas of the building.

Answer: Below deck roof insulation and vapour barrier to be removed throughout entire building.

Item 4: Can you clarify that the schedule below is accurate:

- 1) Tender closing date is February 19, 2025
- 2) Tender Award date, Feb 24
- 3) Pre-tender meeting, Feb 25
- 4) Mobilize to site, Feb 26
- 5) Begin abatement/deconstruction work Feb 27
- 6) Order plumbing fixtures, electrical components, doors and windows Feb 24. These items are a minimum of 6 weeks (to be confirmed at time of order). This means that we are beyond the March 31 deadline and will not turnover the building interior.

Answer: Respondents shall assume the following dates:

- 1) Tender closing date is February 19, 2025
- 2) Tender Award date, March 3
- 3) Pre-Construction meeting, March 10
- 4) Mobilize to site, March 14
- 5) Begin abatement/deconstruction work March 17

Background Information

The Diesel Shop, originally built in the 1974 and extended in 1992, it is now in need of repairs due to its age. In response to this, ONTC had made the decision to complete building upgrades and repurpose the facility to host the Ontario Northland Infrastructure Maintenance of Way crew.



Schedule of Work

The scope of work will be phased over two fiscal years and in two phases (*Note – Ontario Northland's Fiscal year runs from April 1 to March 31)

Phase I –

- February 2025 to March 31, 2025 (FY 2025),
- 40% of the Scope shall be completed during this Phase I
- Scope of Work: interior, mechanical and electrical upgrades

Phase II -

- April 2025 to July 31 2025 (FY 2026)
- 60% of the Scope shall be completed during this Phase II
- Scope of Work: exterior upgrades










Drawings-Floor Plan




















Drawing- Electrical New Construction
