Please refer to the following information/clarification:

**Item 1:** Has ONTC had any discussion with the Town of Cochrane for it to accept the waste material from the buildings to be demolished at Island Falls? If so, can we be provided with the contact person?

**Answer:** ONTC did have conversations with Jared Alcock that was in charge of the Public Works department. He had said that we could use the local landfill site. Unfortunately, he has left the Town of Cochrane and we do not have another contact. The Town of Cochrane can be reached out at

**Item 2:** Will ONTC be paying the landfill tipping fees or is the responsibility of the contractor?

**Answer:** It is the contractor's responsibility to pay the tipping fees.

**Item 3:** Is ONTC providing railway transportation to and from the site for the contractors required personnel, equipment and material?

**Answer:** Contractor will be responsible to contact ONTC to secure the required equipment to transport the equipment, personnel and material to and from the site. ONTC will provide the track protection required for the work

**Item 4:** Will daily drop off and pick up of our workforce be provided by ONTC from ONTC's Island Falls garage to the bunkhouse location?

**Answer:** Contractor will be responsible to contact ONTC to secure the required equipment to transport the personnel.

**Item 5:** Will the contractor be able to use the siding at the bunkhouse location and have up to 3 rail cars stay there while work is being performed?

**Answer:** Yes, the contractor will be able to have 3 rail cars on the siding during the work.

**Item 6:** Will we be able to discuss and or confirm railway transportation logistics with ONTC in advance of the RFP being awarded?

**Answer:** Contractor/bidders should contact ONTC's Rail Services to discuss and or confirm railway transportation logistics and costs. These costs should be included in the bid package.

**Item 7:** Will it be possible to unload heavy equipment, of up to 25 tonnes, off a flatbed railcar at the bunkhouse location siding?

**Answer:** There are ramps on the flat cars that will allow unloading.
